If you are a resident of Lakewood and paid up member of Lakewood Civic Association, Boat Club dues are \$40 per year **beginning at the May annual meeting**. If you have not already paid your Lakewood Civic Association dues of \$30, you must pay them at the time you join the Boat Club. Boat Club fees for Lakewood Estates residents are \$75. A limited number of “out of the neighborhood” memberships are available for \$150 per year. The fee for a late season Boat Club membership (January through May) is ½ the total fee (\$35 for residents, \$37.50 Lakewood Estates, \$75 non-residents) and will expire at the annual meeting in May.

## Mid-May 2025 - Mid-May 2026 MEMBERSHIP AGREEMENT

1. The Lakewood Boat Club launch is to be used by **MEMBERS ONLY**.
2. **Membership registration will be available at the annual LCA meeting and periodically at scheduled sign-up times.** Individuals seeking membership "on demand" will not be accommodated and will need to wait until the next available sign up day/time. You are expected to have all the required information when you sign up.
3. Boat launch operations shall be administered by a committee or person appointed by the Lakewood Civic Association (LCA) Board.
4. Membership shall be typically open **ONLY** to either Lakewood residents (this shall include Pointe Royale and Caldwell Oaks) or Lakewood Estates residents. Lakewood residents must be Lakewood Civic Association members to have a membership in the Boat Club. Applicants may be asked to provide proof of residency at the time of application. The number of Memberships outside these neighborhoods is set by the Lakewood Civic Association Board.
5. The LCA board will establish an annual fee sufficient to cover expenditures. This amount is in addition to Lakewood Civic Association dues.
6. **KEYS CANNOT BE DUPLICATED.** Your key is numbered and your name is recorded as the "owner" of this key. We reserve the right to check ownership of keys at any time. Allowing non-members to use your key is a disservice to club members and if discovered could result in suspension of launch privileges.
7. The lost key fee will be \$20.00. Loss of more than one key in a 5 year period will result in membership suspension that can only be reinstated by vote of the LCA Board.
8. Parking is **LIMITED**. Therefore it is **Restricted** to one vehicle per membership pulling a boat and trailer or one carrying a boat!! If you plan on fishing at the pier, you need to unload your equipment and **PARK OUTSIDE**. Avoid blocking driveways in consideration of the homeowners on South Burnett. Extra vehicles may be towed at owner's expense.
9. **Close and Lock the gate going in and coming out.** Do not leave the gate open or unlocked.
10. Use facilities at your own risk. LAKEWOOD CIVIC ASSOCIATION IS NOT RESPONSIBLE FOR LOSS OR INJURY. IF YOU FEEL A PARTICULAR PROBLEM IS A DANGER TO USERS, CONTACT THE BOAT CLUB ADMINISTRATOR OR THE LCA IMMEDIATELY.
11. Facilities are not to be used by individuals under age 16 unless accompanied by a parent or responsible adult who is a Boat Club **MEMBER!**
12. Be considerate of residents living on the bay. Boats driven at high speeds along the shoreline speed up erosion and damage bulkheads.
13. Trash pick-up is not available at the launch. Take YOUR trash home with YOU!
14. Do not deface, modify, or hang string from pier.
15. The LCA reserves the right to limit the number of club memberships and to revoke or reinstate club membership.

I understand the above rules and requirements. I understand my membership can be revoked and my membership fee will not be refunded if I or members of my family or guest:

- Do not abide by the above stated rules or
- Are using the facility in an unsafe manner, or
- Creating a nuisance.
